We are building, growing and transforming this organization together, and these accomplishments — and those that are on the horizon — belong to us all. Thank you for giving what you can to the life-giving river we love.



Our ecologists actively restored and maintained 34 sites across the metro region creating wildlife habitat, improving water quality and strengthening climate resiliency.



Supporting pollinators through restoration and research

You've seen the reports of worldwide pollinator decline. Our Land Conservation team works to counteract that trend, focusing on pollinator habitat in all of our restoration efforts. In 2023, we monitored for impact, applied innovative methods to break up monocultures of invasive species, and increased our capacity for research and community science.



"Over the past five years, FMR has worked with our neighborhood to save 8-acre River Heights Park in Inver Grove Heights and restore prairie there with native plants. Together we've planted the seeds, created a small demo garden and conducted pollinator surveys. Without FMR's leadership, we wouldn't have a plan to determine the condition of the 1,850-foot-long cutoff wall 40 feet beneath St. Anthony Falls. We do know that if the wall were to fail, it could compromise our water supply and threaten nearby roads and bridges.

In 2023 we led the campaign to educate the public and decision-makers about this hidden hazard, and it paid off. The Legislature awarded \$1 million to investigate the wall — a first step in protecting our cities and the only waterfall on the Mississippi River.

Growing the market for clean-water crops through value chain development

FMR and our partners designed a state investment program to develop value chains for clean-water crops. Thanks to legislative wins in 2022 and 2023, businesses could apply for grants last spring. Companies like Perennial Pantry can scale up their operations, and groups like Regenerative Agriculture Alliance can facilitate advancements for small farmers. That means you'll be able to buy more Kernza baked goods, hazelnut snacks and other tasty products soon. Minnesota will see more acres of these crops on the land and cleaner waters as a result.
