'Efforts to reintroduce bison to Dakota County park advancing this winter'

Could Minnesota have a self-sustaining bison herd again? Our Dakota County partners are contributing to the possibility by preparing a fenced-in area of prairie at Spring Lake Park Reserve for 15 of its own bison to roam. The bison won't move in until the fall, but when they do, their grazing habits and even hooves will encourage plant growth and diversity, restoring relationships that existed for centuries prior to European colonization.

'Work could begin soon to bring St. Paul's Phalen Creek back to the surface'

Lower Phalen Creek Project is leading the charge to daylight Phalen Creek, essentially unchanneling sections from pipes, allowing parts of the creek to once again meander above-ground on the way to the Mississippi River from Lake Phalen on the east side of St. Paul. The creek was originally sunk underground in the 1920s to make way for development. But creeks provide stormwater management, habitat, cultural and community connection and more — and this one will again.

Our comments on Minnesota's 2022 Impaired Waters List

We gave feedback on the proposed updates to Minnesota's Impaired Waters List for 2022, along with our partners. We focused on three key pollutants: "forever chemicals," nitrate contamination, and sulfate in wild rice waters. Notably, many wild rice waters in Minnesota have damaging amounts of sulfate, but not all of them made it on the state's list.


