Clean-water crops: Good for the environment and the economy

FMR loves the environmental benefits of <u>clean-water crops coming out of the U of M</u>. But we're just as jazzed about the economic growth opportunities they open up. That market potential was on display during an event at PURIS' facility in rural Dawson, Minnesota, earlier this month. The pea protein company hosted a few state lawmakers to show off its revitalized plant that employs about 100 people, and to talk about the economic potential of a crop rotation that includes both peas and a winter annual crop (such as camelina, being developed by the Forever Green Initiative). Those crops "could be very interesting for us," PURIS CEO Nicole Atchison told the Marshall Independent.

Where to find fall colors in mid-October

The Minnesota Department of Natural Resources' official Fall Color Finder map has become a go-to resource for leaf peepers and autumn seekers each September and October.
